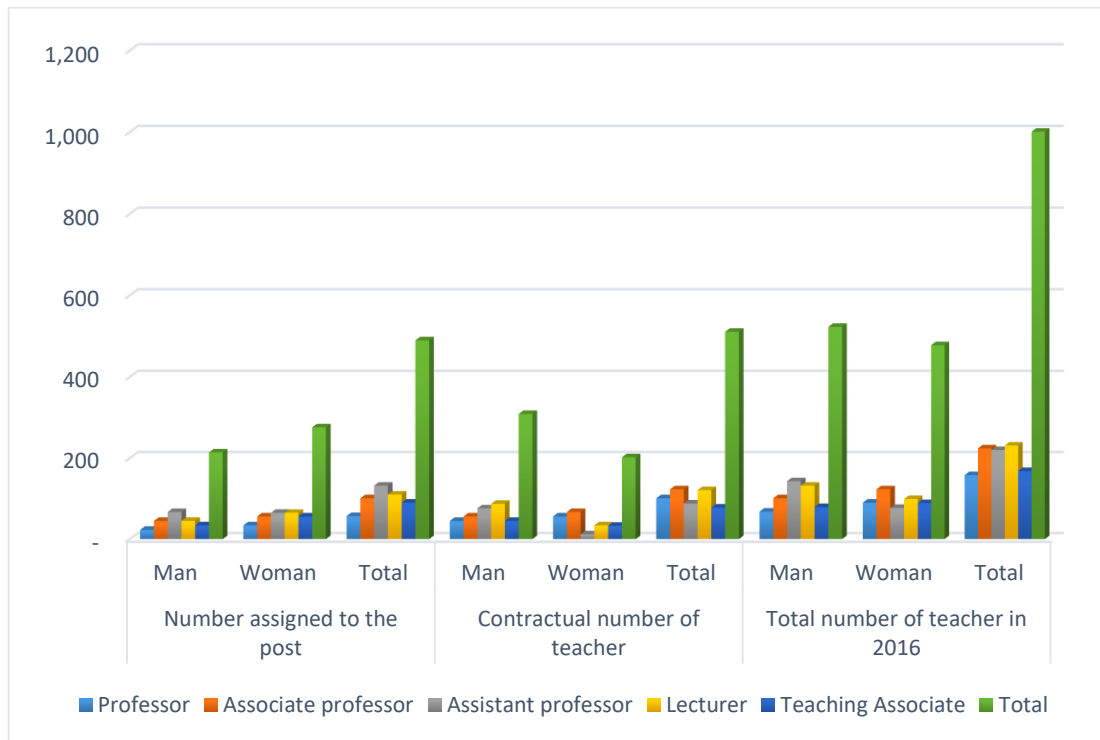


Figure 1: Total number of teacher of in 2021

Here we see the total number of teacher in 2021. We can say from this chart that the number of woman teacher are few.

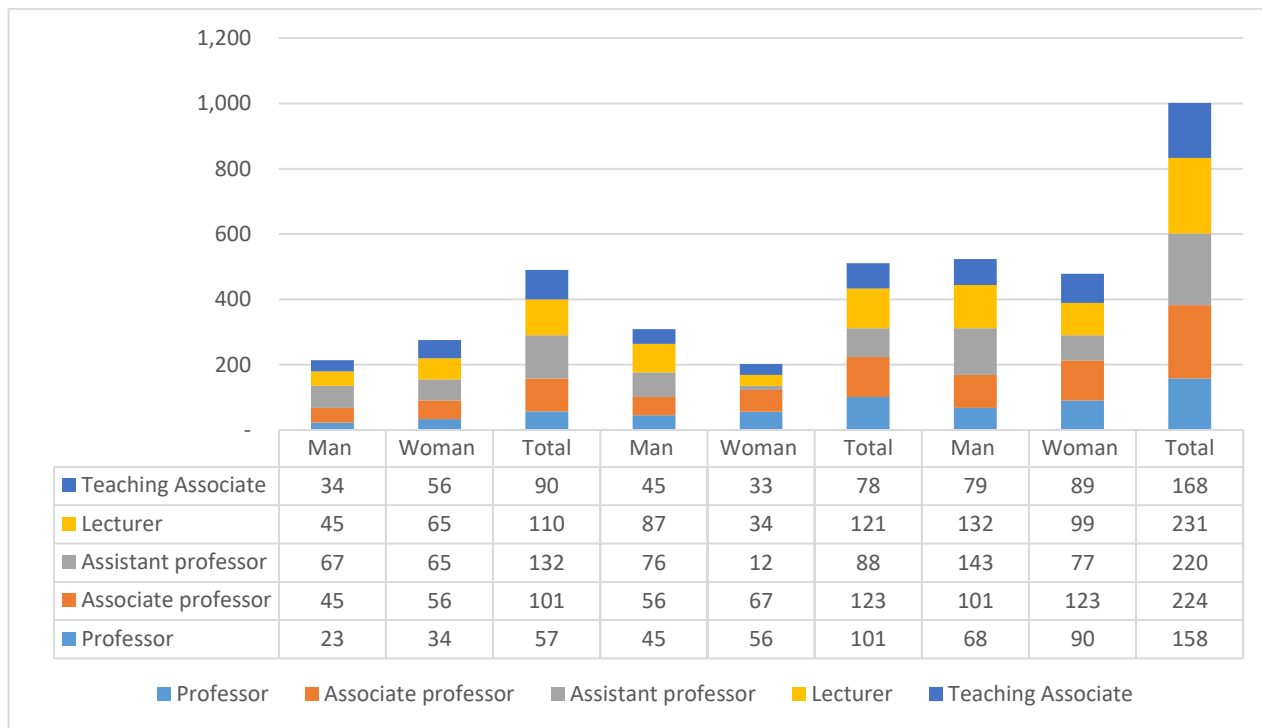


Figure 2: Degree Statistics of Teachers in 2021

Here in the figure says that degree statistics of teacher in 2021 are good. The number of full time teacher need to increase than part time teacher.

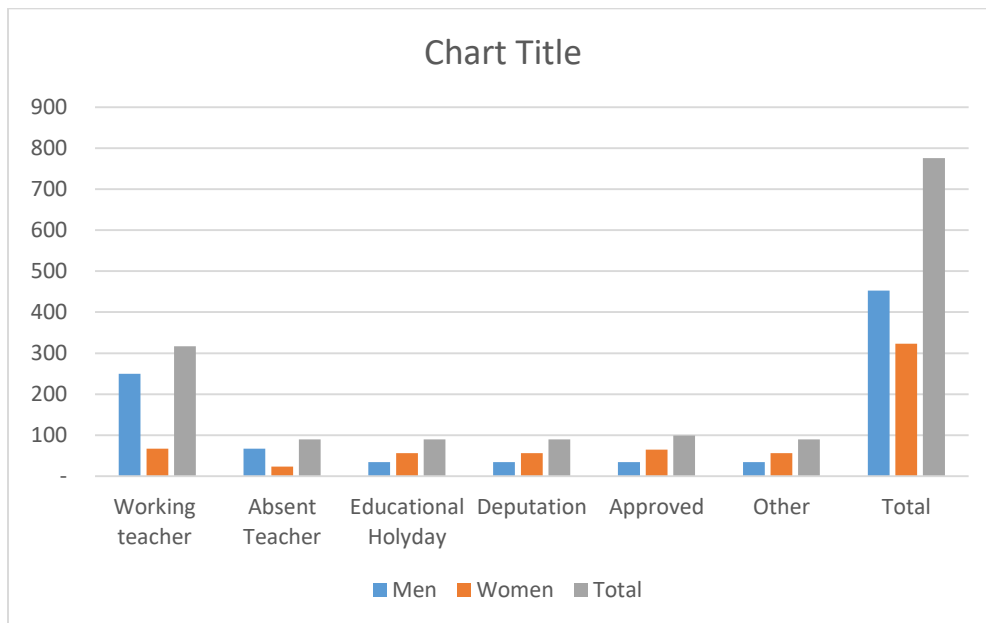
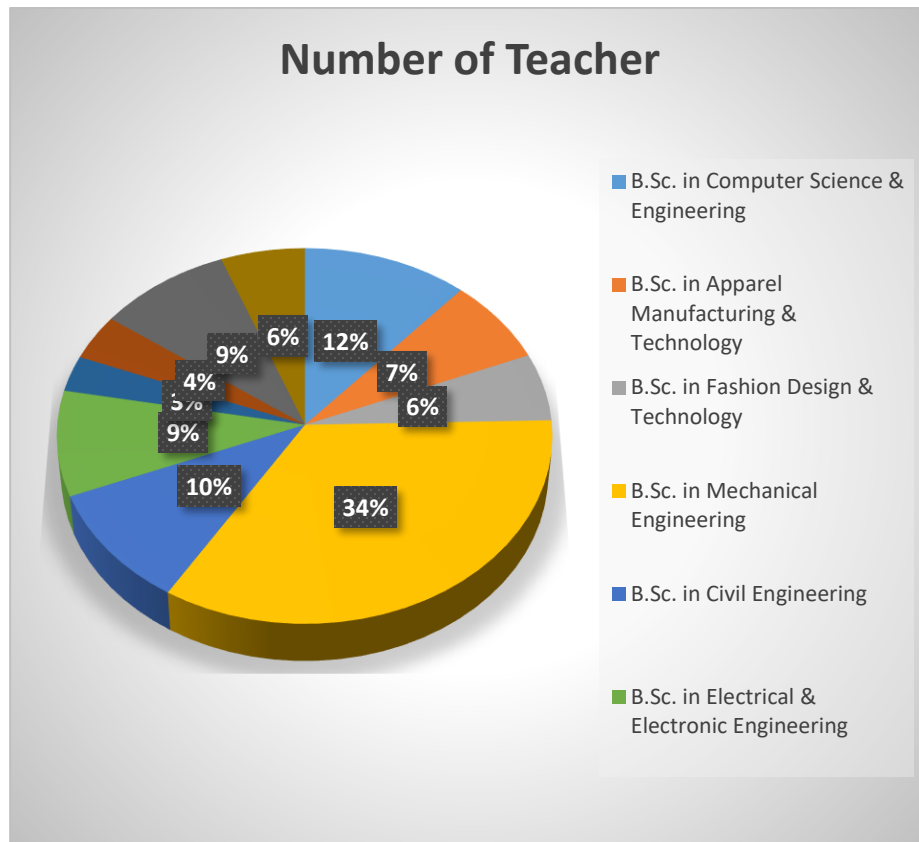


Figure 3: Working and Absent Number of Teachers in 2021

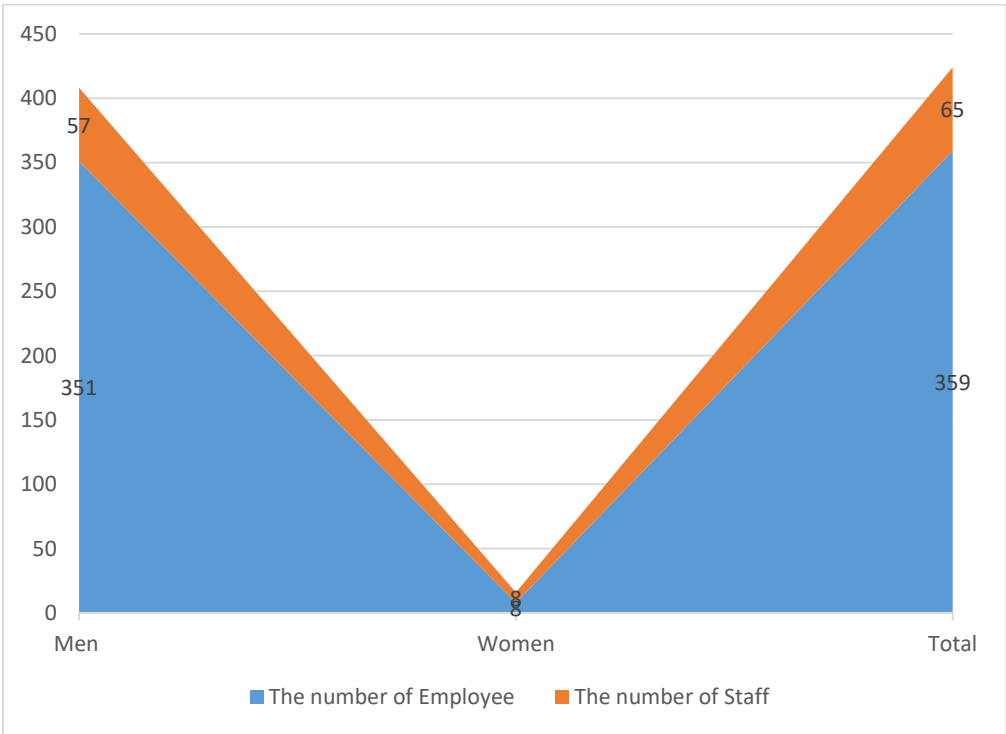


Figure 5: Staff and Employee Statistics in 2021

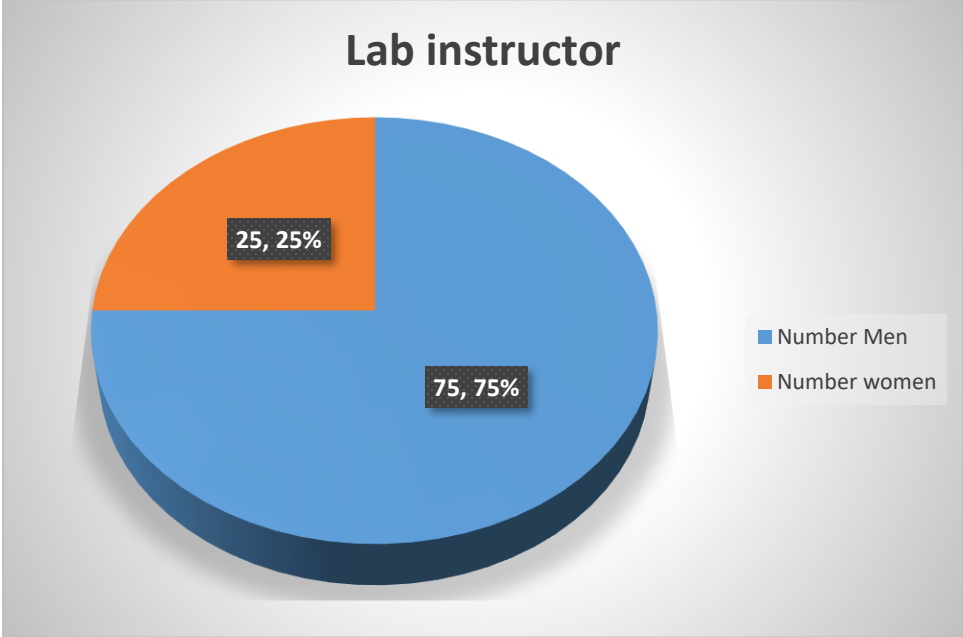


Figure 6: Engaged in Technical Work Staff and Employee Statistics in 2021

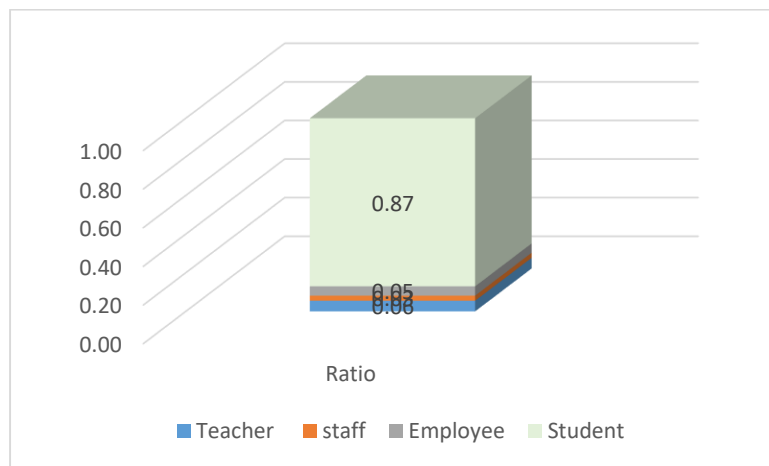
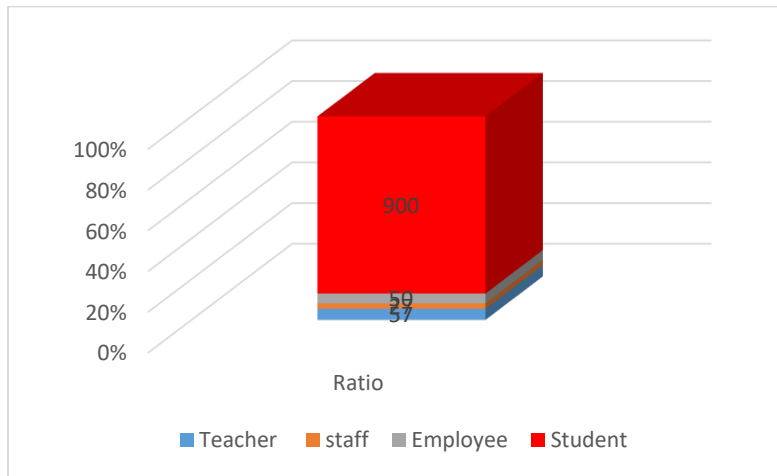
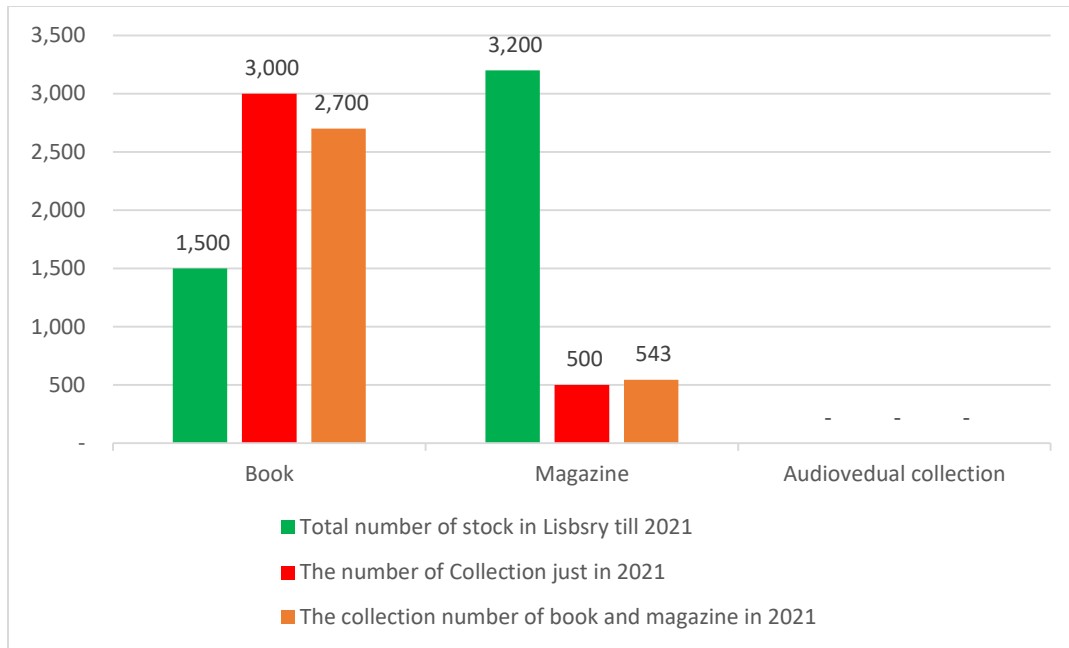


Figure 7: Ratio of Teachers, Staff, Employee and Students in 2021

Here in figure says the description of library in 2021. In 2021 book collection was near 1500.

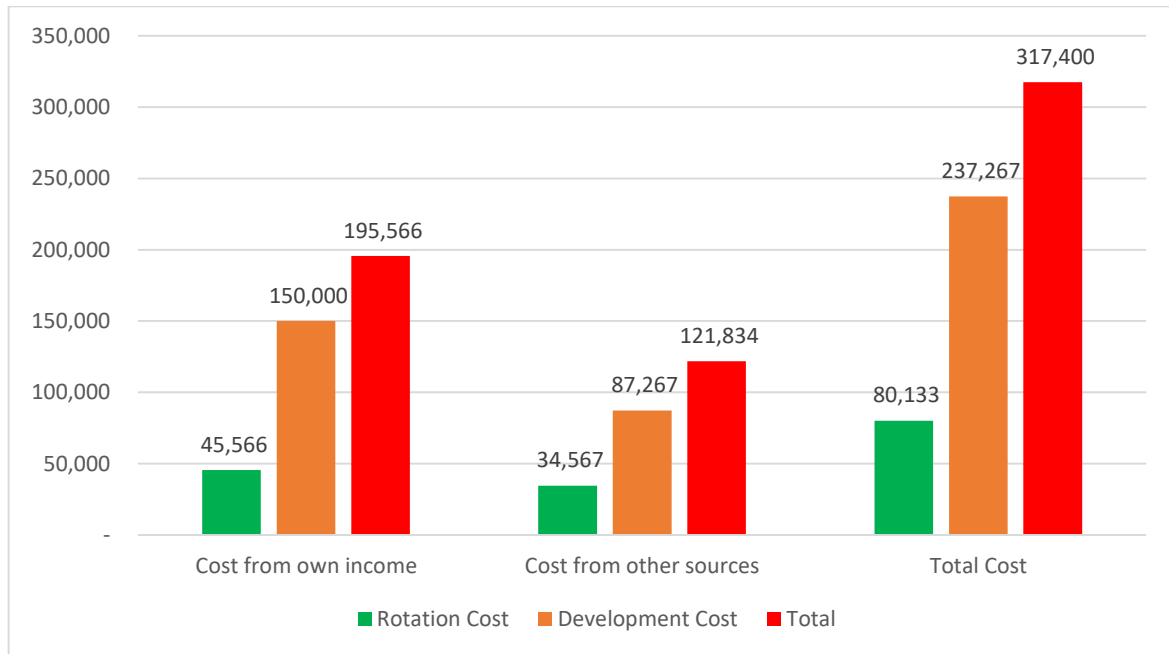


Figure 9: Collecting of spending money on Library in 2021

Here this figure shows the cost from own income and other sources. The number of cost from other sources are more than the cost from own income of this university.

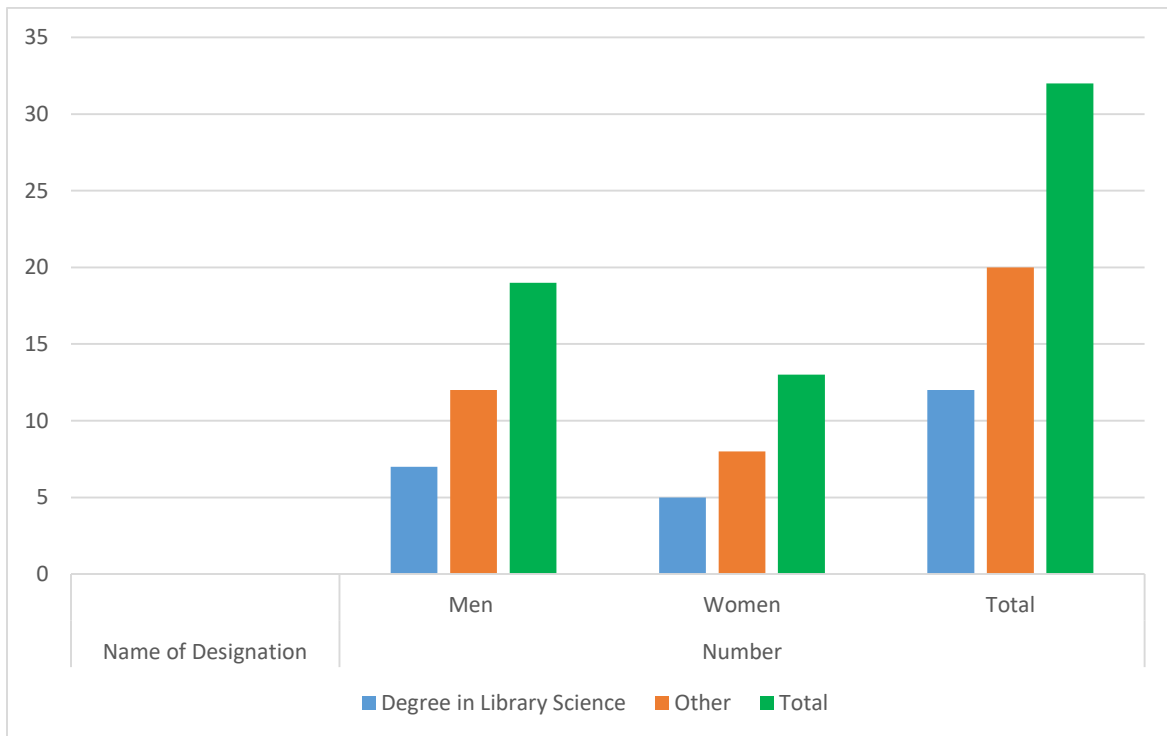
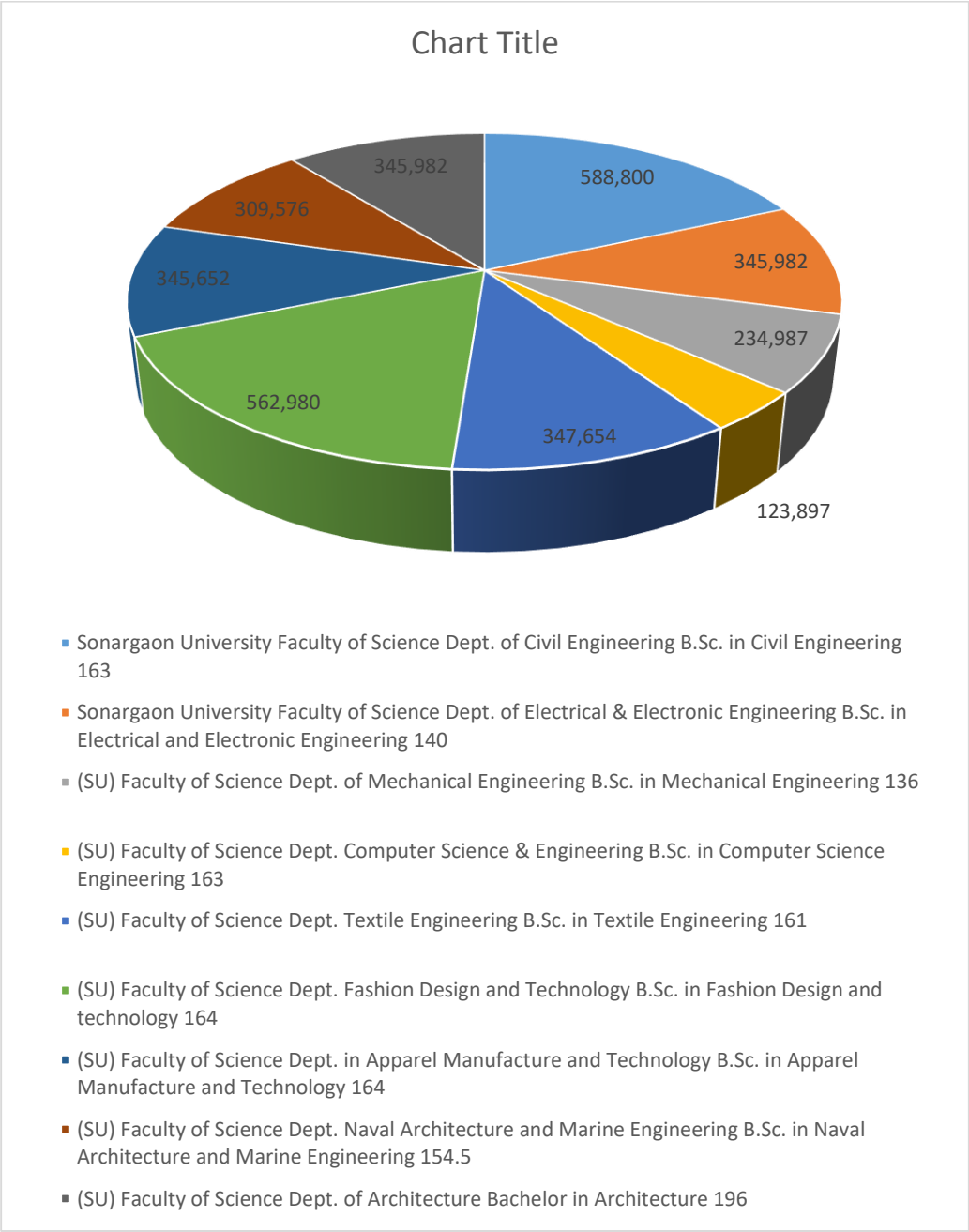


Figure 10: Working Manpower in Library in 2021

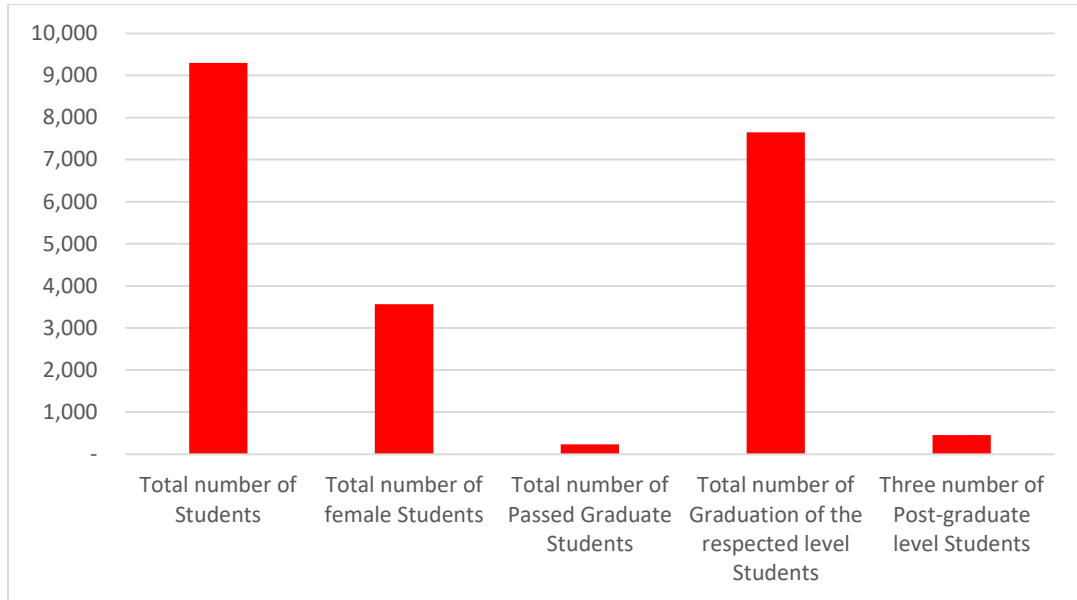


Figure 12: Statistics of total studying student

This figure shows the statistics of total studying student in 2021 we can see from this chart that total number of graduation of the respected level students are more than the number of postgraduate level in 2021

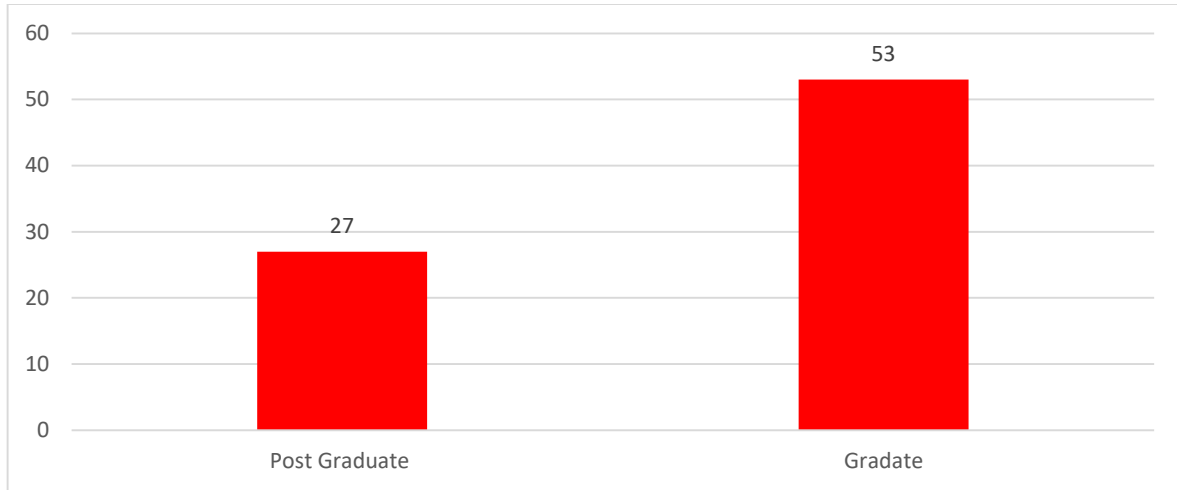


Figure 13: The number of passed out students of degree based

Postgraduate student in number are less than the graduate student in tech and engineering.

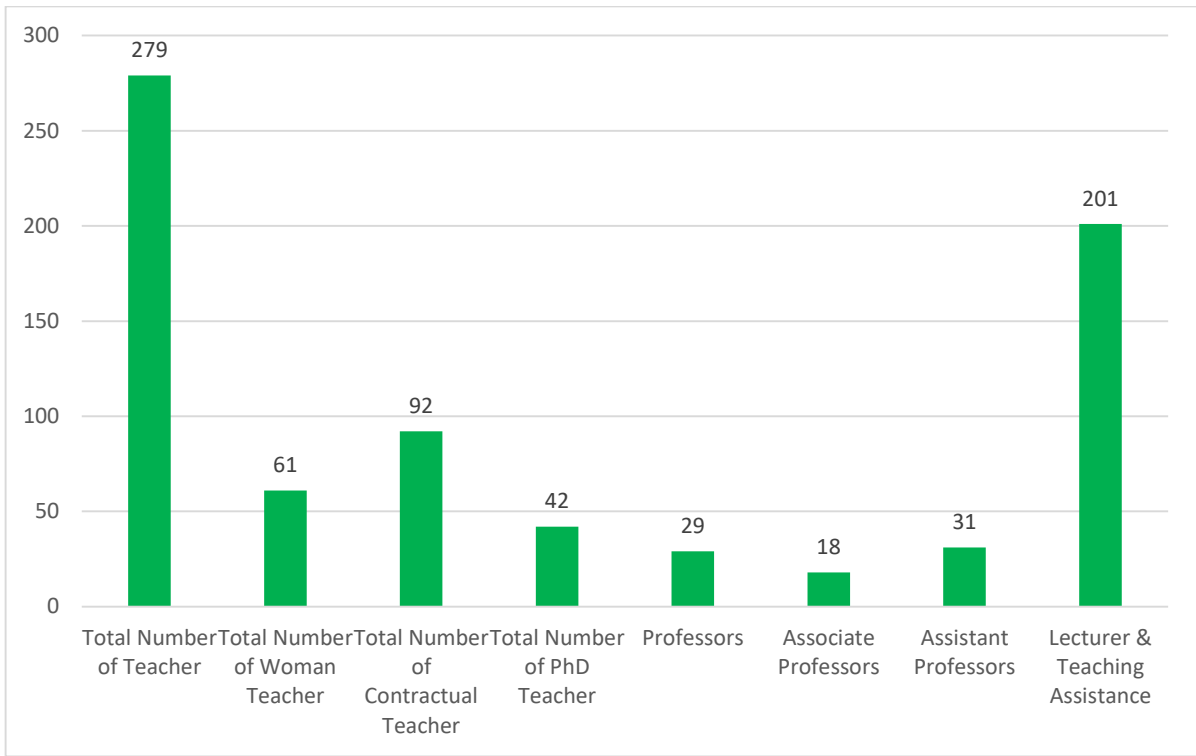


Figure 14: Teacher Statistics

This figure shows the statistics of the total number of teacher in 2021. Here teacher with lecturer and teaching *assistance designation* are more in number than any other designated teacher.

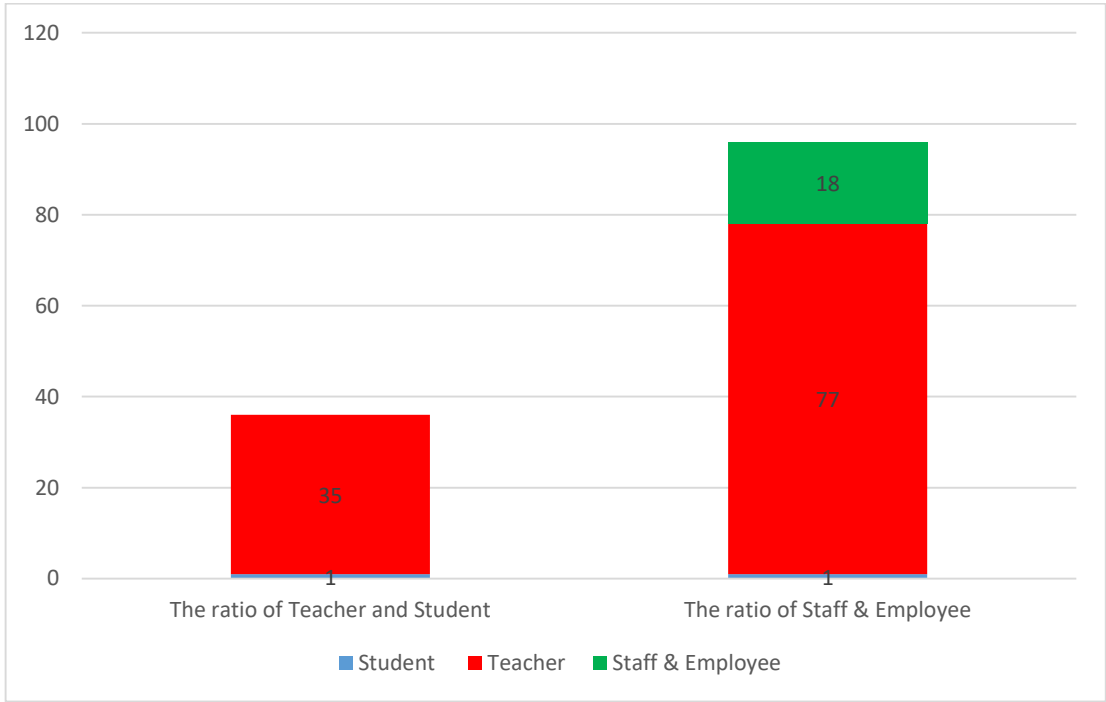


Figure 14: The statistics of Staff and Employee

This figures states the statistics of staff and employee here we can see the ratio of teacher and students are 1.22 and staff, employee and students ration are 1.18

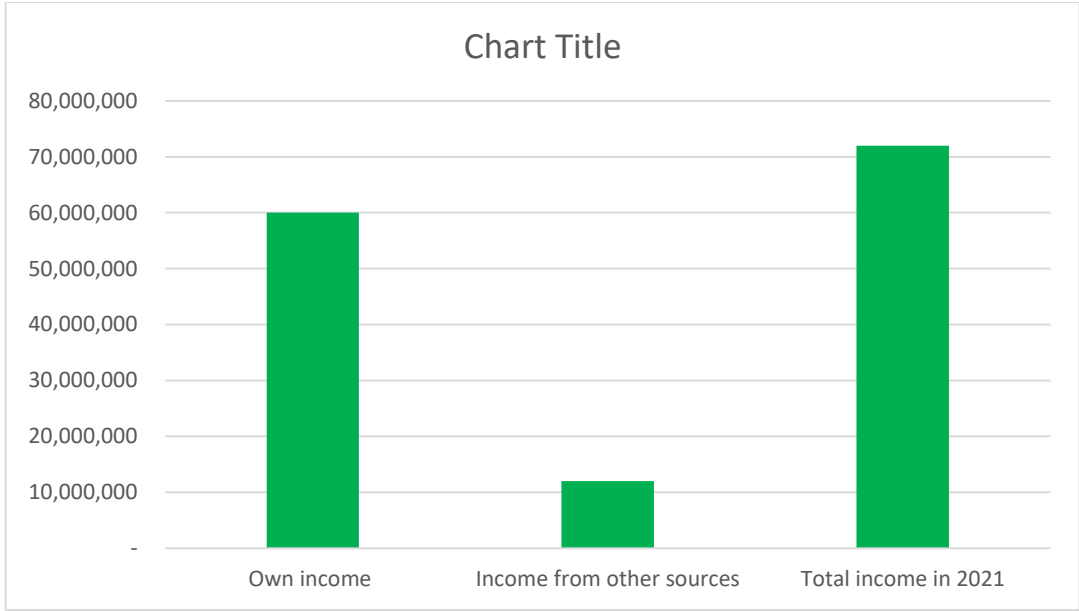


Figure 15: Total income in 2021

We can see the total income in 2021 in this figure. Income from own sources are less than the income from sources.

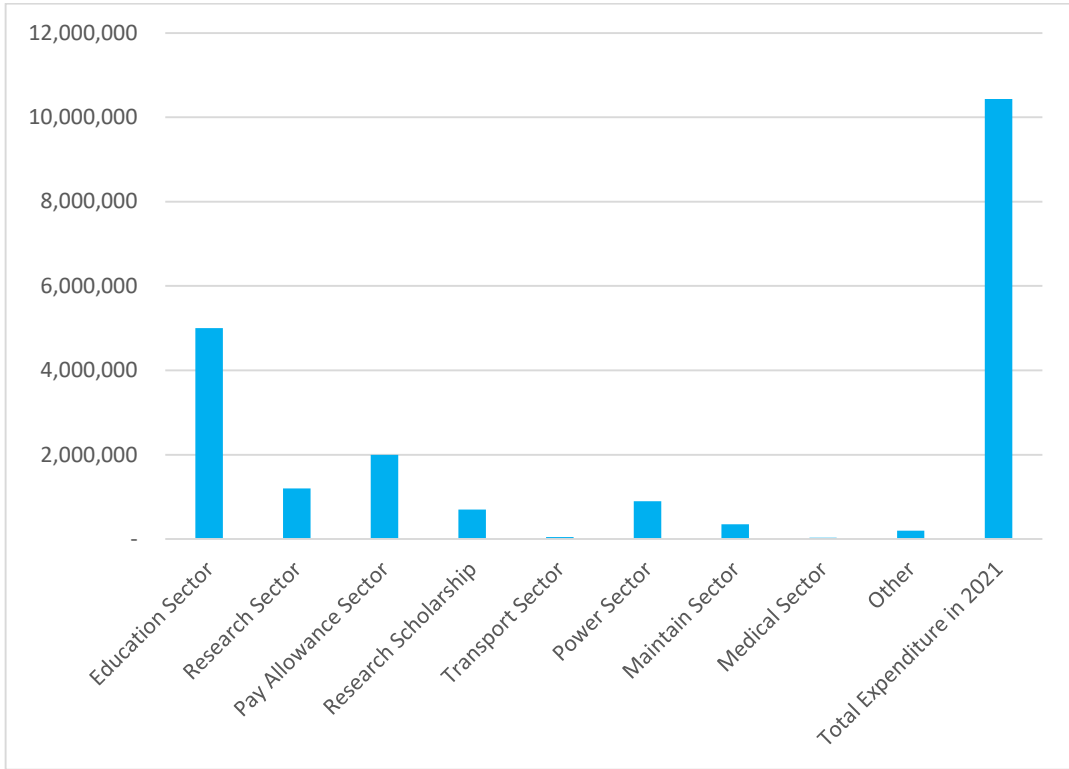


Figure 16: Total expenditure in 2021

In this figure we can see the total expenditure of this university in 2021. Expenditure in education sector are more than any other sector in 2021 of this university.

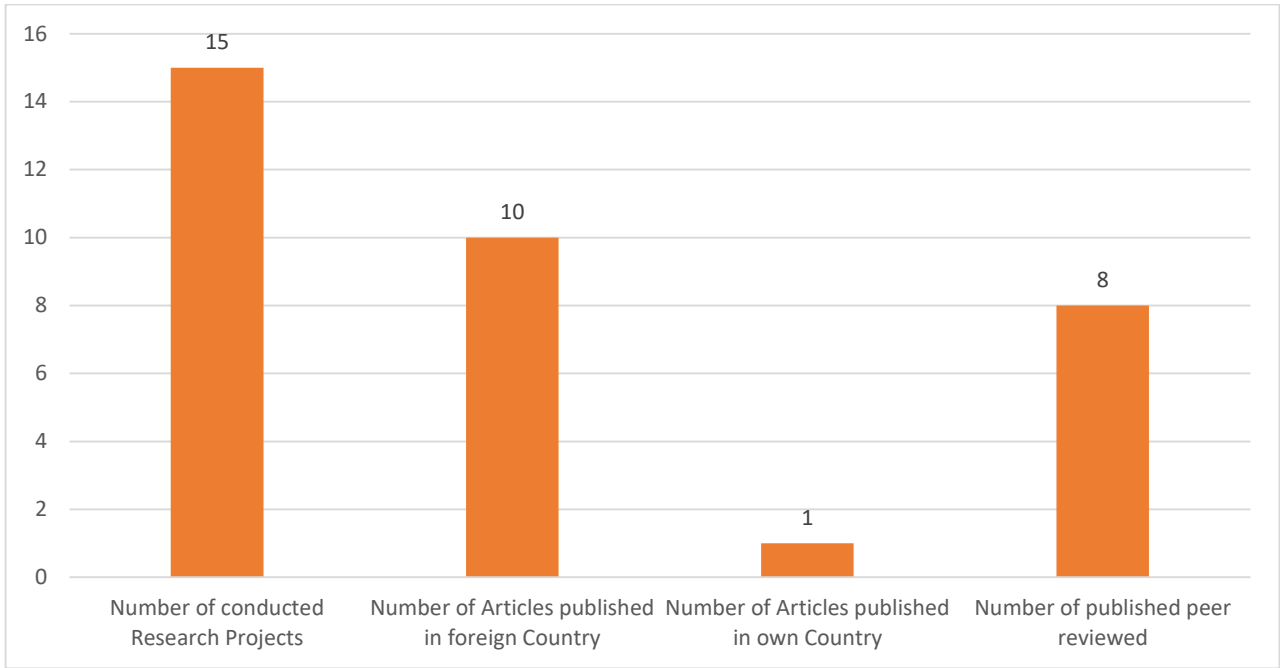


Figure 17: Library Table

Here we can see the total description of library in 2021. Here total stock numbers in library content are 1800 and acquisition are 3.

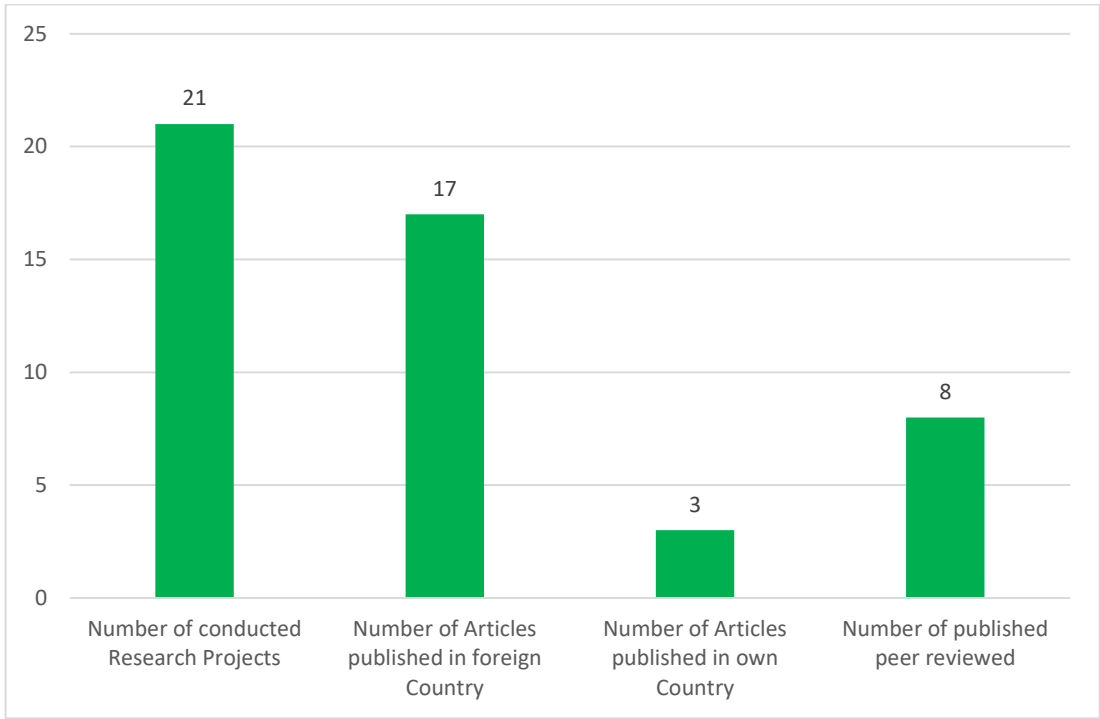


Figure 18: Research Table

This figure states that description of the research sector. Here we can see the number of an article published in own country are less in number in research sector in 2021

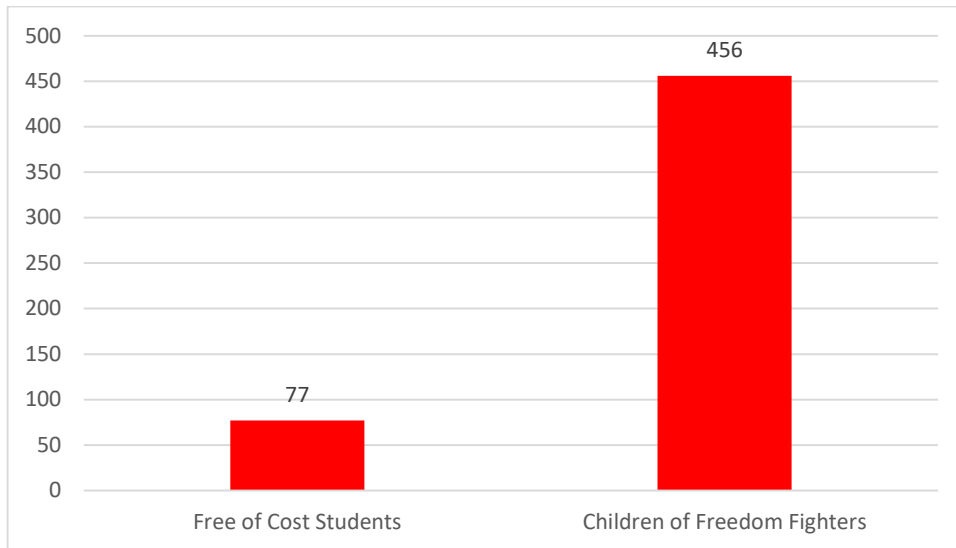


Figure 19: The number of free of cost students and children of the freedom freighter

Findings:

- Students appreciate the value of a university degree, indeed many of them seeing it as an absolute necessity for career success.
- They, often reluctantly, state they would be prepared to pay whatever was asked to get a degree
- However, many question whether the current delivery of the degree represents value for money; common complaints are: lack of close contact with tutors and lecturers, boring lectures with lecturers simply reading from notes or summarizing textbooks, inappropriate timetabling, no contact with leading researchers, coursework no being marked.
- When asked what universities should be spending scarce resources on there was a strong preference for more staff and better library resources, while there was a much lower rating for improved teaching accommodation and student union/leisure facilities. As one student put it, we are here to get a degree not to have fun'
- Most students found the switch to university teaching and learning styles hard, especially the switch from what many described as 'spoon-feeding' at school to Independent learning.
- Large impersonal first-year classes exacerbated the problem
- Student from disadvantaged backgrounds struggle to pay living expenses, leading many to take up term-time work which effects their performance' others choose to live at home a miss out on student social life.
- Competition for internships and vac schemes is fierce and depends a lot on 'who you know'
- Students from privileged backgrounds are better placed to make strategic choice to further their careers.
